Logging Para meters - Self potential, short normal (N-16), Long Normal (N-64), Lateral. Details of major Aquifer formations explored from logging of bore hole combined with the study of Strata Chart prepared from drill cuttings are given in the following table:-

- 2. The zones marked with asterisk (*) appear to be aquifer zones for possible Development of tube well.
- The Quality of water is expected Medium.
