A Deep bore hole was drilled 130 mtrs. depth. and Logged depth 130 mtrs. at above site. Was drilled by M/S PNC-SPML-JV, Badaun.

On the request of M/S PNC-SPML-JV, Badaun. a Geophysical well Logging is conduct at above bore hole using IGIS Well Logger on 30.Oct.2023.

Logging Para meters - Self potential, short normal (N-16), Long Normal (N-64), Lateral. Details of major aquifer formations explored from logging of bore hole combined with the study of Strata Chart prepared from drill cuttings are given in the following table:-

- The zones marked with asterisk (\*) appear to be aquifer zones for possible development of tubewell.
