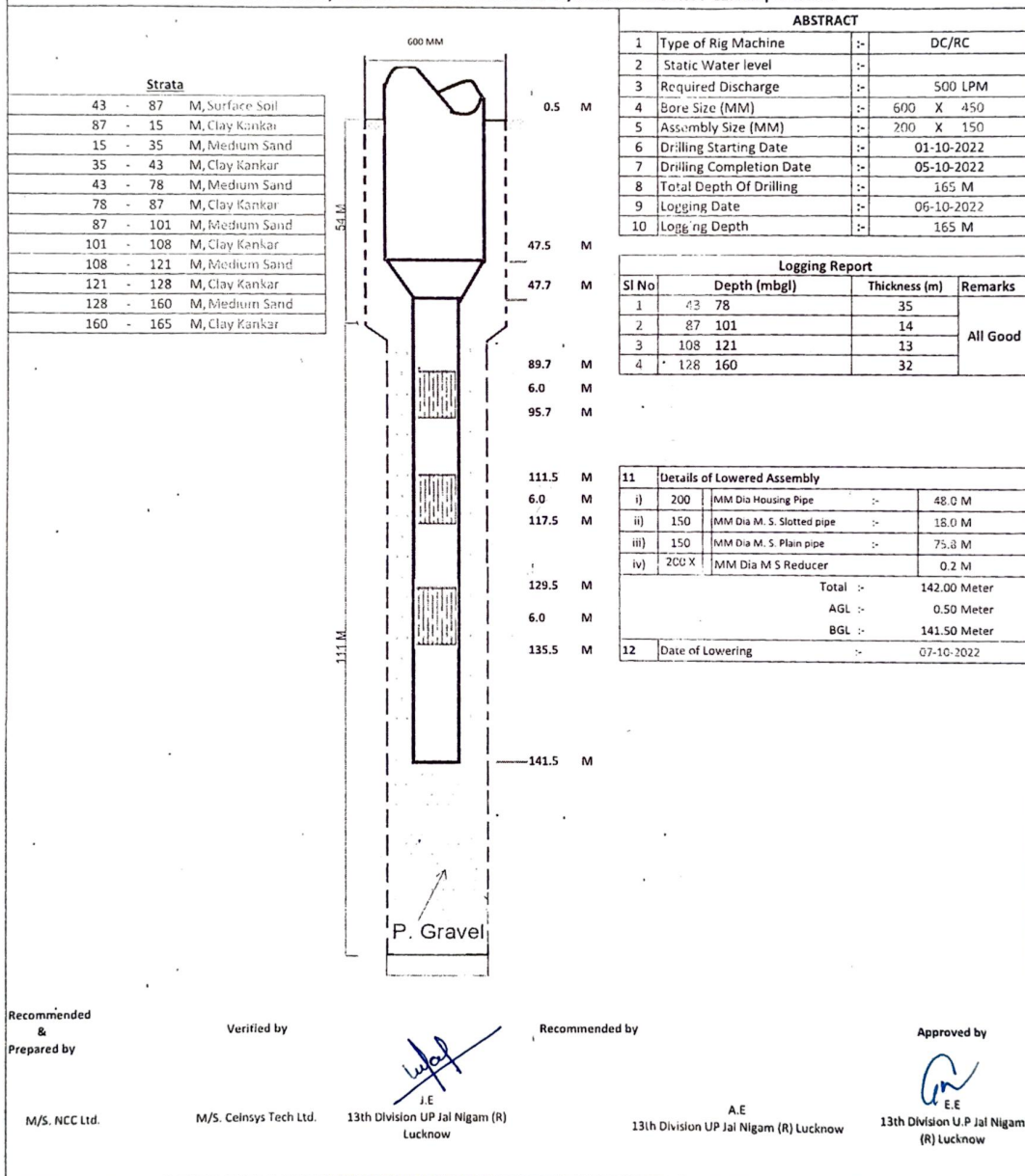

REPORT ON GEOPHYSICAL WELL LOGGING AT

Introduction :

A Deep bore hole was drilled 165 mtrs. depth. and Logged depth 165 mtrs. at above site. Was drilled by M/s NCC Ltd., Lakhimpur Khiri.

On the request of M/s NCC Ltd., Lakhimpur Khiri. a Geophysical well Logging in the above bore hole using IGIS Well Logger on 06.Oct.2023.

Logging Para meters - Self potential, short normal (N-16), Long Normal (N-64), Lateral. Details of major Aquifer formations explored from logging of bore hole combined with the study of Strata Chart prepared from drill cuttings are given in the following table:-

Mud Resistivity = 21.56 Ohms.

Drilling Water Resistivity = 22.40 Ohms.

Approx Water Level = 3 Mtr.
