- 2. The zones marked with asterisk (*) appear to be aquifer zones for possible development of tubewell.
- 3. The Quality of water is expected Medium.
- 4. It is recommended to have a chemical and bacteriological analysis of the water sample before using it for human consumption or for any other use.
