On the request of M/S PNC-SPML-JV, Badaun. a Geophysical well Logging in the above bore hole using IGIS Well Logger on 22.Aug.2023.

Conclusions and Recommendations :-

- 1 The Lithology broadly tallies with that of drill cutting starta chart.
- 2 The zones marked with asterisk (*) appear to be aquifer zones for possible development of tube well.
- The Quality of water is expected Medium.
- It is recommended to have a chemical and bacteriological analysis of the water sample before using it for human consumption or for any other use.
